Terms and Conditions

Your entry is confirmed upon our receipt of your completed online entry form and deposit.

Please note our acceptance of your booking brings into existence a legally binding contract between us, on these terms and conditions only.

Fees, including any additional charges (ie. train fare), are due **in full** prior to the start of Camp. Full payment is required by 1st July of the year in which Morland Choristers' Camp takes place.

We request that payments are made following the timetable below:

Date/Reference	Cost

1st March (or upon submission of Entry Form if made after 1st March)	50% remaining balance
1st July	Remaining balance

Payment must be made in pounds Sterling by credit/debit card, BACS, or by cheque.

For those in financial need, Morland Choristers' Camp is happy to accept payment for Standing Order instalments. Bursary funded places are also available. Please contact admin@morland.org.uk in confidence to discuss options.

In the event of late/non-payment, we reserve the right to cancel your booking and not accept future applications. We also reserve the right to charge interest on outstanding amounts at the rate of 2% per calendar month. Failure to attend the event will result in the full cost being incurred. No refund shall be given.

Attendance and Cancellations

Attendees will receive preparatory information and instructions via email to the email address provided on the Entry Form.

Upon signing up to Morland Choristers' Camp, the attendee is committing to attend the full duration of the event's published dates. If this is not possible, the attendee must put their absence request in writing as soon as possible (ie. late arrival, early departure, or absence during the event), and Morland Choristers' Camp reserves the right to reassess their general attendance.

All requests for cancellations must be received in writing and must not be assumed to be accepted until you have received notification in writing.

As Morland Choristers' Camp engages staff members, venues, vendors, and other facilities/services many weeks in advance, a charge may apply for cancellations (please see below).

Deposits are non-refundable. In the case of cancellations, a cancellation fee may be charged. Please see the table below for details:

Calendar days' notice before the start of Camp	Refund applicable
28 days or more	100% refund*
14-27 days or more	50% refund*
Fewer than 14 days	No refund
Failure to attend without notice	No refund

* (minus deposit and a 10% cancellation fee to cover admin costs)

Should a place be booked late (within 14 days of the commencement of Camp), and subsequently the participant cancels their place, no refund will be given.

Morland Choristers' Camp reserves the right to cancel the event. The participant may request a refund, or subject to availability, transfer the booking to a future Camp. Should it be cancelled by Morland Choristers' Camp, we will endeavor to inform all participants at the earliest possible convenience. Morland Choristers' Camp will not accept liability for any consequential loss and shall have no liability to reimburse any other costs that may have been incurred, including transport, accommodation, etc.

Data Protection

Morland Choristers' Camp needs to process personal data (including but not limited to name, email address, phone, address) for the execution of this contract. We will keep this personal data for no longer than is necessary.

Force Majeure

Morland Choristers' Camp shall not be liable to refund of fees or for any other penalty should the event be cancelled due to war, fire, strike lock-out, industrial action, tempest, accident, civil disturbance, pandemic, or any other cause beyond their control.

Entire Agreement

These terms and conditions, together with the current Morland Choristers' Camp website prices, event details, and contact details, set out the whole of our agreement relating to the event. These terms and conditions cannot be varied except in writing signed by the Chair of the Trustees of Morland Choristers' Camp. In particular, no terms and conditions incorporated within any purchase order and nothing said by any person on behalf of Morland Choristers' Camp should be understood as a variation on these terms and conditions.
